A Study on the Causes of the Disintegration of the Soviet Union in Chinese High School History Textbooks

Abstract: The disintegration of the Soviet Union in 1991 is one of the most important research topics in the history circles at home and abroad, and also an important knowledge point in the world history part of history teaching in middle schools in China. This paper selects the representative history textbooks of high school in China as the research object, summarizes the contents of the selected textbooks about the disintegration of the Soviet Union, focuses on the description of the causes of the disintegration of the Soviet Union in the history textbooks, summarizes and analyzes the contents, so as to let the Russian people understand the Russian concept of history in China's high school education, and promote the cultural exchanges between China and Russia. **Keywords:** Disintegration of the Soviet Union; History Textbooks; Cause

1. Introduction

Textbook is a kind of teaching book compiled according to a certain curriculum standard. It is the core teaching material. It is a comprehensive summary and systematic discussion on the existing knowledge and achievements of a certain discipline, which is related to the implementation of teaching activities and the improvement of teaching quality^[1]. Middle school history textbooks are an important part of middle school textbooks, which are usually compiled according to the syllabus or curriculum standards issued by the state education administrative department. It systematically and concretely presents the basic content of history discipline, and reflects the basic requirements of "curriculum standard" that students must master the most basic historical knowledge, the ability training of history discipline and the basic requirements of emotional attitude and values education^[2,3]. It is not only the "learning base" for students to learn history course, but also the main basis for teachers to organize history teaching activities. As an important carrier of cultural heritage and continuation, it is related to the formation of the values and world outlook of the training object. This paper selects the representative Chinese high school history textbooks as the research object, summarizes the contents of the selected textbooks about the disintegration of the Soviet Union and analyzes the reasons. The purpose is to let friendly neighboring Russia understand the image of Russia reflected in China's current mainstream world outlook, promote cultural exchanges between China and Russia, and understand the Russian history in China's high school education on the basis of relevant research Historical view.

2. A summary of the disintegration of the Soviet Union in Chinese high school history textbooks

The disintegration of the Soviet Union is a necessary point in the history textbooks of Chinese senior high schools, as well as the examination points of college entrance examination^[4]. Chinese high school history textbooks have studied this topic in a wide range. This study collected five sets of Chinese high school history textbooks, a total of 12 volumes, respectively: "history compulsory 1", "history compulsory 2", "history elective 3-20th century war and peace" (2007), compiled by the People's Education Press Curriculum Textbook Research Institute and History Curriculum Textbook Research and Development Center, and published by the People's Education Press; "history compulsory Volume 1" and "history compulsory Volume 2" (2009), edited by Zhu Hanguo and Ma Shili, and published by People's Publishing House; "history compulsory 1", "history compulsory 2", "history elective 3-20th century war and peace" (2010), jointly compiled by senior high school history textbook compilation group and DC Canada International Exchange Center, senior high school curriculum standard experimental textbook published by Beijing Normal University Publishing House; "history compulsory Volume 1", "history elective 3-20th century war and peace"

(2009), edited by senior high school history textbook compiling group, elephant publishing house and DC Canada International Exchange Center, and published by Elephant Press; "history compulsory 1-the course of political civilization", "history compulsory 2-the course of economic growth" (2004), published by Yuelu Press.

These 12 history textbooks are applied to senior high school history education in different regions of China. Although there are differences in arrangement, they are mainly in the form of chronicles. The chapters and titles of the contents about the disintegration of the Soviet Union in the five sets of textbooks are shown in **Table 1**.

In the five sets of textbooks, compulsory textbooks on the disintegration of the Soviet Union are not introduced as a special section or topic content, but are discussed in the change of the world system. The main structure is as follows: the world pattern \rightarrow the great changes in Eastern Europe and the disintegration of the Soviet Union. In addition to the required textbooks, there are also elective textbooks in this paper. The elective course of history in senior high school is a learning content for students to choose. It aims to further stimulate students' interest in learning, expand their historical vision and promote their personalized development. In the process of compiling and teaching history elective course, relevant learning contents can be added according to the actual situation. The content of the disintegration of the Soviet Union was arranged in history elective 3-20th century war and peace. All textbooks take the disintegration of the Soviet Union as the dividing line, representing the end of the cold war and the beginning of global multipolarization.

3. The causes of the disintegration of the Soviet Union in Chinese high school history textbooks

In 1999, 2000 and 2001, the Comprehensive Social Research Institute of the Russian Academy of Sciences conducted several surveys, accounting for 66.5%, 63.2% and 57.6% of the respondents believed that the disintegration of the Soviet Union could be avoided, while only 20.3%, 25.4 and 30.0% of the respondents agreed that the disintegration of the Soviet Union was inevitable.

The explanation of the causes of the disintegration of the Soviet Union in Chinese textbooks is basically the same with little difference. The main point of view is that the Communist Party of the Soviet Union gave up the position of the ruling party and Gorbachev's wrong reform. However, the descriptions in various textbooks are also different. See **table 2** for details.

Chinese academic circles have conducted in-depth studies on the disintegration of the Soviet Union from the aspects of politics, history, culture, military affairs and economy. Returning to the textbook level, the authors or institutions of Chinese high school history textbooks have objectively studied and evaluated the issue from the political and economic aspects. The main reasons include that the Communist Party of the Soviet Union gave up its leading position in the country, which led to the serious weakening of power and the outbreak of crisis^[5,6]; the three generations of leaders of the Soviet Union, Khrushchev, Brezhnev and Gorbachev, basically failed in their economic reform, finally, Gorbachev's economic reform turned to political reform, resulting in chaos and deviation from Marxism^[7,8] The external reason was mainly the peaceful evolution strategy of western countries^[9]. The key event of the disintegration of the Soviet Union was the "8·19" incident, and the fuse was the signing of the Treaty of Soviet sovereignty and the union of republics in August 1991^[10]. From the point of view of the focus and content of the analysis, the Chinese history textbook elaborated the event of the disintegration of the Soviet Union from an objective point of view, without giving evaluation and judgment, so that contemporary Chinese high school students can understand the disintegration of the Soviet Union and the history of the Soviet Union from a more rational perspective.

This study holds that the disintegration of the Soviet Union was caused by the accumulation of historical and social problems left over by the Soviet Union for a long time. The main reasons are as follows: firstly, the Communist Party of the Soviet Union gave up the leadership position of the ruling party; secondly, the economic root, failed to solve the economic problems from the national conditions of the Soviet Union, did not deal with the economic crisis in time, the domestic development was unbalanced, and the understanding of the basic domestic contradictions was improper, which led to the emergence of the economic crisis; thirdly, it did not deal with the economic crisis in time, did not correctly judge the national conditions of the Soviet Union and went to the wrong political reform. The disintegration of the Soviet Union is a tragedy. Its disintegration raises many sharp questions to Marxism Leninists all over the world. It is the bounden duty of every theorist given by history.
