

Therefore, relevant colleges and universities in this category should be equipped with enough on-site instructors for the relevant activities to be carried out according to the characteristics of their own colleges. First, they can ensure the smooth progress of the activities. Second, they can check the overall situation in the process of the activities and put forward their own guiding opinions, which can play a good guiding role in the physical and mental health of college students.

2. The college shall establish a strong and relevant student organization team

First of all, we should innovate the selection measures and methods of the backbone of students' related organizations. As the core figure of an organization, especially the student education organization, we must have high ideological and political consciousness, good character, learning ability of various skills, certain working ability, be able to comprehensively coordinate and organize various activities in line with the characteristics of students, play a leading role in the organization, and have a certain spirit of sacrifice, Enhance the centripetal force and attraction of the student organization, so as to make the organization better serve teachers and students. In the election of the core figures of the student organization, the internal members of the student organization should select the core person or person in charge of the organization from bottom to top. The relevant counselors, teachers, instructors and relevant departments of the school should not interfere too much, so as to let better people who are more in line with the characteristics of the organization lead and organize the Department.

In the process of assessment and performance evaluation of the organization, there should be self-assessment of members' internal personnel, mutual assessment among members, and comments from instructors. While organizing their own summary of work results, they should pay more attention to objective reflection. The most important thing is that student organizations should reasonably plan the construction of their own team, Due to the different characteristics and majors of students, there is a large mobility within the organization. We pay more attention to the cultivation of organizational transmission power. We must avoid the fault of talent echelon in organizational development. Only by reasonably building their own organization and relevant echelon personnel can we better serve students and teachers.

3. Expand new opportunities for young students' voluntary service

In recent years, college students' voluntary service has developed rapidly, especially the young college students in the second university. All colleges and universities are establishing young volunteer service posts or volunteer posts, and some second universities have set up volunteer service departments in their own student unions. However, the field of voluntary activities of most college students is too narrow and limited to the mode of supporting education in junior middle school and primary school, offering love and so on. Due to the single mode, most volunteers in the organization are highly utilitarian, either to complete the tasks of the superior departments of the school or college, or to give extra points in the evaluation of excellence and awards, lacking their own initiative. Therefore, college students' voluntary service should take refinement as the activity concept and innovate the "brand" project [2].

Build a reasonable mechanism for relevant students to participate in management, solidify this concept in the constitution of each university, and restore it to the root purpose and purpose of the student organization, which should not become a puppet of governments and schools at all levels. Only in this way can the secondary student organization form a benign and harmonious relationship with functional departments at all levels and reflect the real connotation of the autonomy of a student organization.
